All Aruba cloud services, including Private Cloud, Public Cloud, Cloud Backup and Cloud Object Storage, comply with the Code and guarantee certified security and transparency for their users.

Arezzo, 14 February 2017 – Aruba S.p.A. (www.aruba.it), a leader in web hosting, email, certified email (PEC) and domain registration services, also a founding member of CISPE (Cloud Infrastructure Services Providers in Europe), has today declared - together with a coalition of 15 leaders in the field of cloud computing infrastructure services from 7 different countries (Italy, France, the Netherlands, Spain, Finland, Luxembourg and Bulgaria) - its compliance with the CISPE data protection Code of Conduct, for all services provided under its Aruba Cloud brand (www.arubacloud.com).

Less than 6 months after being presented to the European Parliament, the code is about to come into force. Numerous surveys have shown that 90% of European citizens want the same data protection rights across Europe. Consequently, the member companies of CISPE are working hard to achieve this goal.

All cloud services declared to be compliant with the CISPE Code of Conduct are identified by a specific compliance mark, offering customers and citizens the choice to store and process their data within the European Economic Area. This mark also guarantees that the provider of cloud services will not access or use the customer's data for their own purposes, in particular, data mining operations, data profiling or direct marketing.

Aruba also declares that its Private Cloud, Public Cloud, Cloud Backup and Cloud Object Storage services meet the requirements stipulated by the CISPE code.

The Code can be used by customers seeking a cloud provider offering infrastructure services, as a tool to establish whether a service appropriately and transparently protects the data they want to keep. The Code offers benefits to both customers and the providers of cloud infrastructure services:

- it provides concrete solutions to the growing demands and requirements of customers right across Europe, in anticipation of the implementation of the new European data protection regulation in 2018 (GDPR);
- it clarifies the distribution of responsibilities between the customer and the providers of cloud infrastructure services;
- it further defines the CISPE requirements, depending on the nature of the data processing undertaken by CISPE itself;
- it requires CISPE to be transparent in meeting these requirements, providing the basis for mutually beneficial cooperation between CISPE and the customer
